## POWER OF ATTORNEY

for out of court representation of all kinds as well as for a lawsuit and all proceedings on all levels of jurisdiction.

This Power of Attorney particularly grants the authority

1. to provide out of court representation and to conduct out of court negotiations of all kinds
2. to enforce claims against the liable party, registered car owner and their insurance provider in case of an accident
3. to provide representation in private and statutory arbitration proceedings
4. to establish and terminate contractual relationships as well as to issue and receive unilateral statements of intent (e.g. terminations)
5. to conduct litigation (i.a. pursuant to §§ 81 ff. ZPO)
6. to file petitions in divorce proceedings and post-divorce proceedings, to conclude agreements on divorce settlements as well as to file petitions for disclosure of information on pension and other annuities
7. to provide representation and defense in criminal matters and matters concerning administrative fines (§§ 302, 374 StPO) including pre-trial proceedings, as well as (in case of absence) representation in accordance with § 411 II StPO and, with express authorization, pursuant to §§ 233 I, 234 StPO, to file complaints as well as other petitions permitted by the German Code of Criminal Procedure and to abandon them, and to provide representation as joint plaintiff in a lawsuit. With respect to petitions pursuant to the German Act on Compensation for Wrongful Prosecution this Power of Attorney also applies to proceedings concerning the amount of compensation
8. to provide representation before administrative authorities, the social court and fiscal court
9. to provide representation before the labor court
10. to terminate a lawsuit or other negotiations out of court by means of settlement, other forms of consent, waiver or acknowledgement
11. to appeal to court and abandonment of the appeal as well as waiving of such
12. to receive and effect service and other notification
13. to provide representation in all ancillary and subsequent proceedings, e.g. arrest and restraining order, cost-assessment proceedings, enforcement proceedings including special proceedings arising from these, insolvency proceedings, foreclosure proceedings, forced administration and bailment proceedings
14. to receive the respective amounts of money and necessary expenditures to be reimbursed by the opponent, court cashier or other bodies
15. to receive and to release money, valuables, documents, reliabilities and notably the value in dispute as well as bond and compensation money
16. to assign the Power of Attorney in whole or in part to others
17. to access records
18. to provide representation of all kinds pertaining to probate matters as well as against and before probate court

Exoneration from medical confidentiality relating to the attending physicians is herewith issued. The Power of Attorney and the mandate granted solely apply to legal counseling. Fiscal counseling, commercial counseling, investment counseling or other non-legal topics as well as activities that are subject to authorization without any authorization being present are not subject of this mandate. It is consented to the authorized law firm taking action without further delay.
